AN ESTIMATE OF THE COLLEGE'S TAX LIABILITY FOR THE FEDERAL EXCISE TAX IS \$700,000 AT JUNE 30, 2022, WHICH HAS BEEN RECORDED AS FEDERAL INCOME TAXES PAYABLE ON THE CONSOLIDATED
